Did you know . . .

- A total of approximately \$14.6 million in federal funding was obligated for projects in the greater Battle Creek area in fiscal year 2013 - this is almost three times as much as was programmed in 2012, due to some major MDOT projects and the ability to spend some prior year funding on the part of the local agencies and transit.
- Several categories of federal funding are available to the BCATS area for local projects, including: small MPO area surface transportation, transportation alternatives (formerly transportation enhancement), safety, congestion mitigation air quality improvement (CMAQ), rural, and transit operating and capital funds. In addition, the Michigan Department of Transportation (MDOT) uses many categories of federal funds to maintain and improve the interstates and state trunkline roads in the area. All categories represent federal gas tax revenues coming back to the local community.
- A total of about \$1.76 million in federal funds was obligated for projects benefitting improved air quality and \$1.076 million was obligated for non-motorized facilities. Obligated transit projects totaled approximately \$1.38 million in federal funds in 2013.

BCATS Reports Obligated Federal Transportation Projects From FY 2013

A major responsibility of federally designated metropolitan planning organizations (MPOs) is the development and management of a document and process termed the <u>Transportation Improvement Program</u> or TIP. The TIP is the short-term implementation component of the 20-year long range <u>Transportation Plan</u> that each MPO develops and maintains to plan future improvements to the transportation system.

Under the federal SAFETEA-LU transportation legislation (passed in 2005), the TIP changed from a three-year to a four-year programming document and the MPOs were to report to local officials and the public an "annual listing of obligated projects" after the end of each programming year. The programming year is a fiscal year that runs from October 1st through September 30th of the following year. This requirement continues under a new federal MAP-21 bill (see box below).

Therefore, the Battle Creek Area Transportation Study (BCATS), the metropolitan planning organization for the greater Battle Creek area, is pleased to provide a listing of the federally funded projects which were obligated during fiscal year 2013 (which ended September 30, 2013). Important to note is that the projects were "obligated" (ie: funding was appropriated) - but not necessarily completed. Some projects actually constructed during 2013 may have been "obligated" in earlier fiscal years and will not appear on this listing. Conversely, some projects "obligated" in 2013 may not be constructed until 2014. The listing of 2013 obligated projects for the BCATS area appears on the reverse of this sheet. New Federal Legislation to affect future year funding . . .

Due to the passage in July, 2012 of a new two-year federal transportation bill, "Moving Ahead for Progress in the 21st Century", known as MAP-21, there were major changes to the federal transportation funding categories for fiscal years 2013 and 2014. The new bill combined many previous funding categories and changed eligibility for some funding. BCATS has continued to receive federal funding for use on major roadways, (although less than in prior years) as well as a dedicated amount of funding for air quality improving projects. There will also continue to be a state application process for projects involving non-motorized transportation, aesthetics, trails, and other ancillary projects in the "Transportation Alternatives" program. There is also increased national funding for safety projects.
